## Your quide to the November TRF school referendum

Two weeks ago. Thief River Falls Public Schools held a community forum to give residents a chance to learn more about the upcoming referendum from myself and members of the school board. We had a great discussion and I am encouraged by the engagement and enthusiasm shown by our community for our students'

Today, our District faces

threaten to disrupt our ability to maintain our high standards for student education. Over the past 15 years. the formula that Minnesota uses to determine funding has not kept up with inflation. This has not only made long-term investments in education difficult, it has challenged our district's ability to support our existing programming and services. Over the past six years, our district has cut its spending by nearly \$2.7 million in response to this challenge. Still, we face a \$3.3 million deficit by the 2026-2027 school year. While budget cuts are an efficient way to balance the budget, they often require our district to let go of staff members or cut student services to protect basic programming.

How would the district's plan protect stu-

dent programming? Our district is asking voters to consider three ballot questions that would authorize new levies to help stabilize the district's budget, maintain our small class sizes, and help recruit

and retain quality staff. Question One seeks to authorize a new operating levy of \$750 per pupil. This funding would be used to temporarily prevent budget cuts. retain quality staff, and invest in school security, mental health services, and career and technical education programming. Question Two would authorize a capital projects levy of \$800,000 for a seven-year term to complete funding for the district's 1:1 technology plan, and help alleviate pressure on our district's general fund, Question Three would support the same goals as Question One with an additional operating levy of \$407 per pupil. This would add an additional two to three years of financial sta-

bility to our district's budget. Would the proposed levies be permanent? No. If approved, the levies proposed by questions One and Three would remain in place for a 10-year period,

while the capital projects levy would expire after seven years What does the district's 1:1 technology plan

include and how would the referendum impact

For roughly a decade, our school district has provided a device to every student to enhance learning, prepare them for a modern workplace, and allow them to collaborate in real-time with their peers and teachers

beyond the classroom, Question Two of the referendum would complete funding for our 1:1 technology plan, ensuring that all students continue to have access to reliable technology.

How will the referendum affect my taxes? If any of the referendum questions are approved, the

investment(s) will be supported by a property tax increase on properties owned within our district. If approved. a \$150,000 home would see an estimated property tax increase of \$15.06 for Question One. \$4.66 for Question Two, and \$8.18 per month for Question Three, for a total of \$27.90 per month starting in 2024.
